Food Truck Vendors and Artisan Vendors providing food samples / selling non pre-packaged food product must meet special requirements by the Naugatuck Valley Health Department. All forms must be filled out no later than 3 weeks before the event. Please call NVHD at 203-881-3255.

**\*\*Please note that we do not supply any generators. Proper disposal of oil and water from all food trucks is expected. A \$500 fine and notification to NVHD in any case resulting otherwise\*\***

By filling out this form, you are letting us know you are interested and available. This is NOT a confirmation or guarantee of a space. Confirmation and Welcome Packets will be sent out as we move closer to event. Once approved, participation fees MUST be received by due date on invoice or we will release your space. Fees are NON-REFUNDABLE unless the event is cancelled, in that event we will work with brewers and vendors to find a suitable alternate date.

We are working with both State and Local Officials to discuss what, if any, COVID Safety Protocols will be in place for the event. As for now attendees, staff, brewers and vendors will be required to wear face coverings on site unless eating or drinking. We will have social distancing markers in place for patrons as well as a separate socially distanced area for food consumption. Event Staff will thermal scan everyone prior to their entrance on site. It is our hope that restrictions will be lessened as we approach the event date. We will keep you informed as we learn additional information.

Smoke in the Valley reserves the right to EXCLUSIVELY sell bottled water and beer. Vendors may sell non-alcoholic beverages (besides water) at their discretion. All vendors are responsible for providing their own supplies and equipment, including tents, chairs, and tables. Brewer's Ball does NOT supply fresh water or any other utilities to vendors. All vendors are responsible for clean-up of their immediate area at the end of the event. Brewer's Ball will be held RAIN OR SHINE April 25th. Load-in begins at 9:00am Saturday April 25th and spaces will be chosen PRIOR to event. No vendor will be allowed to set-up after 11am Saturday April 20th. NO REFUNDS. We are a rain or shine event. \*\*\*\*ALL FOOD VENDORS MUST OBTAIN A HEALTH PERMIT FOR THIS EVENT FROM THE NAUGATUCK VALLEY HEALTH DISTRICT AT 203-881-3255. All vendors must submit a copy to Smoke in the Valley no later than April 1st, 2026. \*\*\*\*
